**Warden Population Report for February 2025**

Warden Lenkey reported that as of today, there are a total of **215** inmates, with **160** males and **55** females. **Six adult** inmates are currently housed outside of Fayette County with Two Males being at Greene, Two Males and One Female being at Torrence and One male at Somerset. We are also housing One male from Somerset and One male from Washington here. One male juvenile is housed at Camp Hill.

**Adult Probation - Intermediate Punishment Program Report**

Adult Probation Officer Jim Kovacs reported that for the month of January 2025 there were a total of 290 active offenders on probation, resulting in 6,774 incarceration days saved. There were 61 electronic monitoring (EM) installations, and 21 disconnects.

The invoice for Restrictive Intermediate Punishment treatment for the month of January 2025 was \$4,027.77 paid to the Fayette County Drug and Alcohol Commission. Medical Assistance paid a sum of \$4,572.82.

**Juvenile Probation**

Juvenile Probation Officer Townsend reported that there are currently **12** juveniles in placement, **1** in detention at Jefferson County and **3** juveniles on electronic monitoring.

**Courts**

Judge Leskinen reported about a Judicial Seminar and noted that the Fayette County IGNITE program was mentioned.

**CYS**

Director Gina D'Auria had nothing to report.

**Drug and Alcohol**

Director Melissa Ferris reported the services are still being offered with no delays. She is still trying to hire a Certified Recovery Specialist. Discussion from Judge Leskinen about DOJ educating judges on MOUD ( Medical Opioid Use Disorder) and eventual mandate of treatment. Warden Lenkey reported that this is already in the works at Fayette County, that it is included in the PrimeCare contract.

He anticipates it to be started in our facility by April. Director Ferris was unaware, but happy to hear this news.
