Warden Lenkey reported that as of today, there are a total of **235** inmates, with **188** males and **47** females. **Five adult** inmates are currently housed outside of Fayette County with **One** male being at Greene, **One** male at Washington, **One** male and **One** female being at Torrence and **One** male at Somerset. We are also housing **One** male from Somerset, as well as, **Seven** females from Washington here. Also, there is **One** male juvenile at Camp Hill

Adult Probation - Intermediate Punishment Program Report

Adult Probation Officer Britt reported that for the month of April 2025 there were a total of 285 active offenders on probation, resulting in 6,656 incarceration days saved. There were 55 electronic monitoring (EM) installations, and 5 disconnects.
