Paul Medved, Springhill Township Supervisor, said there are concerns from voters voting in district two, especially the older voters. It's only a three to five mile distance between the two locations.

Larry Blosser said this all came about with a letter from Oak Grove Church of Christ saying that they have decided to no longer allow the use of the social hall for voting.

Mr. Blosser has reached out to the supervisors and the party chairs for assistance with new location but there is nothing there.

The meeting was advertised in the Herald Standard and the Daily Courier and ten location in the voting area were posted.

Appalachian Community Center is ADA compliant, large enough to handle the number of voters if the consolidation is done, has easy access in and out and adequate parking.

679 voters would be affected if consolidated.
