CIT TRAINING-2016

During the week of February 22nd through the 26th, FCBHA facilitated the fourth Crisis Intervention Team Training for Fayette County law enforcement. Ten participants enjoyed presentations on 23 different topics provided by experts in each field. The training week culminated with case studies and role-playing to allow the officers to test and polish their new skills. This training reinforces the important bonds and partnerships between Law Enforcement, Advocacy, and Mental Health professionals that aid them in responding appropriately to situations involving persons with mental illness or developmental disabilities. The feedback FCBHA has received is that the training helps participants to reach people and help them in ways they could never have imagined and promotes a sense of trust between someone who needs support and someone who is there to help.

Developmental Disabilities Awareness Month - How it Began!

Proclamation 5613 -- National Developmental Disabilities Awareness Month, 1987 February 26, 1987

By the President of the United States of America—A Proclamation

Nearly four million Americans have grown up with severe physical or mental impairments that have slowed their learning, limited their mobility, inhibited their expression, and rendered them dependent on others for care and assistance.

For many of these people with developmental disabilities there is now the prospect of a brighter future and greater opportunity. Americans are becoming increasingly aware that such disabilities need not keep individuals from realizing their full potential in school, at work or at home, as members of their families and of their communities.

New opportunities have been created through the efforts of those with developmental disabilities and their family members, along with professionals and officials at all levels of government. Working together, they have brought about significant changes in the public perception of young people and adults with developmental disabilities, opening new doors to independent and productive lives.

One important new milestone is the fruitful partnership between government and the private sector in finding productive employment for people with developmental disabilities, people who might otherwise have been destined to a lifetime of dependency. In the past 2 years, the Administration's Employment Initiative has resulted in finding job opportunities for more than 87,000 people with developmental disabilities.

The Congress, by Public Law 99 - 483, has designated the month of March 1987 as ``National Developmental Disabilities Awareness Month" and authorized and requested the President to issue a proclamation in observance of this event.

Now, Therefore, I, Ronald Reagan, President of the United States of America, do hereby proclaim the month of March 1987 as National Developmental Disabilities Awareness Month. I invite all individuals, agencies, and organizations concerned with the problem of developmental disabilities to observe this month with appropriate observances and activities directed toward increasing public awareness of the needs and the potential of Americans with developmental disabilities. I urge all Americans to join me in according to our fellow citizens with such disabilities both encouragement and the opportunities they need to lead productive lives and to achieve their full potential.

In Witness Whereof, I have hereunto set my hand this twenty-sixth day of February, in the year of our Lord nineteen hundred and eighty-seven, and of the Independence of the United States of America the two hundred and eleventh.

News From The Advocacy Network at Mental Health Association of Fayette County

In observance of Mental Health Awareness Month, The Mental Health Association (MHA) of Fayette County will introduce the Advocacy Network to the community with a kick-off event on **Monday, May 2, 2016 from 11:00am-1:00pm**. This historic event marks the first advocacy hub of its kind in Fayette County.

The Advocacy Network has been a work in progress. In 2013, Lisa Ferris, CEO of Fayette County Behavioral Health Administration (FCBHA), responded to feedback from both consumers and providers of mental health services who identified the desire for coordination of supports/resources for easy access. At that time, efforts began to re-organize and coordinate community resources, with a focus on consumer recovery, resiliency and advocacy, into one unified system using peer leadership. The Advocacy Network is the result of this vision. Currently, Partners for Recovery, NAMI (National Alliance on Mental Illness), and Fayette County Youth M.O.V.E. comprise the membership of the Advocacy Network. The intent is to encourage self-determination and combat the stigma of mental illness and all disabilities. Interested groups are cordially invited to complete the new membership process to become part of The Advocacy Network.



Strengthening Families Program

This new program in Fayette County has a mission...to strengthen family bonds. With a curriculum modeled after one developed by the Iowa State University Extension in 1997, the program is geared toward students between the ages of 10 and 14 and their parents. Over a 7-week period, the family skills training program helps parents learn nurturing skills that support their children as well as how to effectively discipline and guide their youth. The program also attempts to give youth a healthy future orientation and appreciation of their parents/caregiver along with skills for dealing with stress and peer pressure. This evidence-based program has been found to improve parenting skills and family relationships in addition to reducing problem behaviors, delinquency, and substance abuse in children while improving social competencies and school performance. Coordinator Jennifer Deichert with the Penn State Extension office in Fayette County says "This is a program that is open to anyone." A recent session worked with parents on brainstorming ways to turn negative speech into positive speech encouraging them to add a compliment. After all, we all want to be appreciated. Two specific programs will meet every week for seven weeks, one at Laurel Highlands Middle School (Tuesdays) and one at Ben Franklin Middle School (Wednesdays) from 6:00—8:30 PM beginning April 5th or 6th respectively. Meetings usually begin with a family meal then divide into two groups; youth and adults. At the end, they meet together as families for the final hour of activities. VIOLENCE Conference: Crisis in our Neighborhoods and Schools

The Crisis Intervention Association of Pennsylvania will hold a Spring Summit on **Monday, April 18, 2016 at Nemacolin Woodlands**. This summit will help identify the psychological and emotional impact of mass violence and trauma suffered by communities throughout the Commonwealth. It will help to identify proactive and realistic actions that community leaders, schools, local/state government, and law enforcement can perform to minimize the effects of mass violence and terrorism. Lastly, it will provide an opportunity to build bridges between government officials, schools, community leaders, law enforcement, first responders and behavioral health professionals and recognize the needs of the community regarding prevention, support during violent events and the after effects of violence. The target audience for this summit is Legislators, County Commissioners, School Superintendents, Police/Fire Chiefs, EMA/EMS, Faith Based Leaders, Crisis Responders (DCORT, KCIT, VOAD, Red Cross, NO-VA, etc.), and Mental Health Professionals.
