FCBHA participated in a first of its kind, Joint Military Suicide Prevention Symposium on June 12, 2013 at the Keystone Conference Center in Fort Indiantown Gap, Pennsylvania. Initiated through the efforts of the Service Members, Veterans, and Family Members Military Policy Academy, and made possible through a grant awarded to the Pennsylvania Adult/Older Adult Suicide Prevention Coalition, it was intended to be a collaboration project designed to determine and plan for the mental health and suicide prevention needs of members of all branches of the military, past, present and future.

The audience consisted of current and former service members, family members, military staff working in the area of suicide prevention, professionals in the field of Mental Health and others interested in preventing suicide among veterans. Among the many distinguished guests was keynote speaker Major General Mark A. Graham who retired from the U.S. Army with almost 35 years of service and an inventory of awards too numerous to mention. Major General Graham poignantly shared his story of losing two sons, Kevin, a Senior Army ROTC cadet studying to be a Doctor at the University of Kentucky who died by suicide and Jeff, a 2nd Lieutenant who was killed by a roadside bomb in Iraq shortly after.

He spoke of how the death of one son was, although a parent's worst nightmare, an element of honor, but that the death of his younger son to suicide was so much more complicated by "the things they did not know". He admits the stigma associated with depression discourages some from seeking help and influences the way the people around them provide support. Both Major Graham and his wife Carol are now determined to use their story to create awareness and educate everyone of what they can do if someone they love is depressed or suicidal ([Go to http://www.fcbha.org/PDF/Major\\_General\\_Graham.pdf for their story](http://www.fcbha.org/PDF/Major_General_Graham.pdf)).

**StrengthofUs.org** is an online community developed by NAMI and young adults. It's designed to inspire young adults impacted by mental health issues to think positive, stay strong and achieve their goals through peer support and resource sharing. We believe every young adult deserves to feel hopeful, supported and encouraged to love who they are.

The website provides opportunities for young adults to connect with peers and offer support, encouragement and advice and share real world experiences, personal stories, creativity, resources and ultimately, a little bit of their wonderful and unique selves. It is a user-generated and user-driven community; so basically it's whatever you make it. Everything has been developed and created by and for young adults with the hope every time they visit, they find hope, encouragement, support and most of all, the strength to live their dreams and goals.



They can create a free account and login to the site to see content available to logged-in users only, including stuff posted by other young adult users. Registered users are able to connect with others on the site, share their own content, write and respond to blogs, comment on content, access "The Wire," join and engage in discussion groups and share videos, photos and other news.

The site also offers resources like guest blogs, tip sheets and media files on issues young adults identified as important to them, including relationships, friends and family, independent living, campus life, mental health and much more! These resources and posts made by SofU Admin are available to the public.

NAMI is the National Alliance on Mental Illness, the nation's largest grassroots mental health organization dedicated to building better lives for the millions of Americans affected by mental illness. NAMI advocates for access to services, treatment, supports and research and is steadfast in its commitment to raise awareness and build a community for hope for all of those in need.

More than 200 young adults shared their feedback, thoughts and expertise for the project by completing NAMI's National survey on their social networking habits, resource preferences and what they wanted included in an online community. The national survey report served as the blueprint for the development of StrengthofUs.org

### **Clinton Anderson, Mental Health Program Manager Retires—July 5, 2013**

Clinton entered the United States Army at 19 and spent time in Vietnam where he was injured in combat. He said he had no intention of working in the field of Social Services but fell into it accidentally when his lawn care business was subcontracting to Goodwill Industries in Uniontown. That was in 1985 and the rest, it seems, is History!

He began at Goodwill as a Business Division Coordinator, later holding positions as Vocational Services Coordinator, and Drug and Alcohol Programs Specialist. He had a hand in the development of a variety of visionary programs. He is particularly proud of the Enclave Model Services Goodwill offered at the time to deliver training, assistance, and specialized supervision to individuals who require ongoing supervision but are able to work in an integrated employment setting.

He came to FCBHA in 2001. Over his 12-year career, he initiated and contributed tremendously to many initiatives such as housing, transitional housing, supported employment and CIT (Crisis Intervention Team) training but may be most proud of his recent passion to implement the Fayette County Treatment Court. This collaborative endeavor between the Mental Health Administration and the Court system created a diversionary court for individuals with Mental Health diagnoses. Treatment Court became a reality in 2009 and has been running successfully since then. In addition to his work at FCBHA, from 2001 – 2010, he was the President of the local chapter of the NAACP and also served for some time as the State Labor and Industry Chairman.

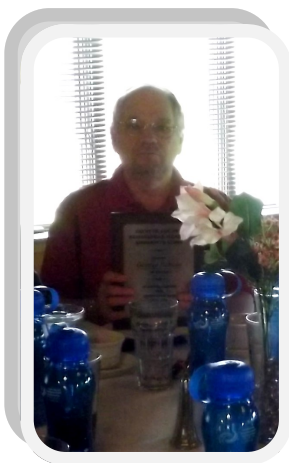

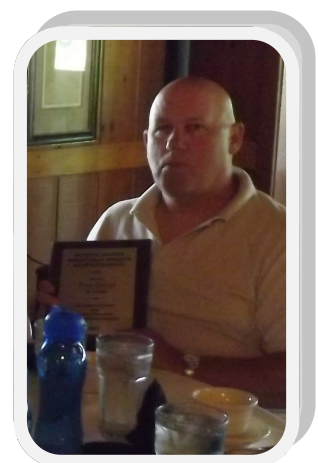

## Reinforcing What Works

Benjamin Franklin once said “By failing to prepare, you are preparing to fail”.

Fayette County currently has programs and initiatives in place to meet the needs of individuals with mental health issues who become involved with the criminal justice system. Since the implementation of the Treatment Court (previously known as Mental Health Court) in Fayette County in 2009, a great deal of effort has been given to the training and preparation of local service providers and members of local law enforcement to enable them recognize those members of society who may be suffering from either mental illness or an emotional episode and react accordingly. The most critical component to the success of this endeavor is for an individual to be identified from the very first moment they are encountered by members of law enforcement.

In December of 2010, the Pennsylvania Mental Health & Justice Center of Excellence and Drexel University spent 2 days in Fayette County to help in identifying points of interface with the criminal justice process, resources, gaps in services, and barriers to appropriate treatment within the existing systems of care. Since then, the Treatment Court and other forensic outpatient programs have operated with great success to serve this special population. It is now time to review, re-evaluate, and readjust to provide for the ongoing success and growth of the effort.

FCBHA will host the Center of Excellence once again for a full day strategic review on August 15, 2013. Key members of the Fayette County Court system, law enforcement, professionals in the field of Mental Health and Public Welfare have been invited to help reinforce our understanding of what is working well and expand on those principles. The goal of the workshop is to further refine the systems and approaches in place and build the capacity to reach out further into the community. By being better prepared to divert individuals with serious mental illness or underlying mental issues to more appropriate levels of care, we can better serve the needs of people overall and perhaps eliminate some overcrowding in the prison system at the same time.
