### Fayette County System of Care Kick Off

This past February, Fayette County became a Pennsylvania System of Care (SOC) Partner. The PA SOC provides technical assistance and funding to achieve systems that are youth / family driven and integrated, value natural and community supports, assure cultural and linguistic competence, and provide data for quality improvement. To officially **Kick Off** the Fayette County / PA SOC partnership, a two day forum was held to reinforce the CANS / Kidnet tools and system and move from assessment to planning with them firmly in place. The CANS/Kidnet infrastructure was implemented in Fayette County approximately two years ago with the goal of having a reliable assessment that can be shared among providers to aid in communication and service planning for children and families. Dr. Steven Herr PHD, CEO of Kidnet and Mark Lardner, MSW, LCSW-C, CANS Implementation Specialist were in town to conduct the meeting and share new information with attendees. Special guests included Clinicians, Direct Staff, Administrators, Evaluators, and Psychologists. Carol Over, FCBHA Consultant also did a great job of tying the principles of the CANS/Kidnet system to the PA SOC / Fayette County initiative. The symposium provided reinforcement of a process that is based around the goal of collaboration and planning to aid in the delivery of services and supports. The impact of the training was a renewed enthusiasm for what can be achieved. Going forward, two 3-hour sessions will be held July 30 and 31, 2014, at FCBHA for family and child providers to continue the process of mapping services in Fayette County. This busy season usually begins with Mental Health Awareness Month and this year was no different. Our goal and theme was to connect and that is what we've done. As a PA System of Care partner, a great deal of energy is being focused on our youth, that is why FCBHA sponsored a **Young Adult Panel Discussion** as the main event for 2014. The event took place on May 8, 2014 at the Fayette County Career and Technical Institute and was facilitated by Dr. Jo Ann Jankoski. Thirteen student participants from Albert Gallatin, Brownsville, Laurel Highlands and Uniontown School Districts discussed issues they are encountering and what can be done to help them manage their decisions more effectively. In the audience were parents and other adults from schools, service agencies, and other community organizations who were able to ask questions. A summary of the discussion produced some recommendations from the students:

- \* Parents should take time and think before reacting
- \* Adults should be better listeners and realize young adults are struggling
- \* Like adults, young adults would like to be respected and valued
- \* There should not be double standards on rules
- \* Adults need to act like adults
- \* Respect . . . you get what you give!



Mental Health First Aid is a public education program which introduces participants to the unique risk factors and warning signs of mental health problems, builds understanding of the importance of early intervention, and most importantly – teaches individuals how to help someone in crisis or experiencing a mental health or substance use challenge. Some additional, more targeted MHFA trainings are being planned for groups such as Law Enforcement –Paramedics –Firefighters; Educators and school support such as custodial and secretarial staff; and Faith-based and Community organizations such as Rotary, Kiwanis, Lions .
