On October 20, 2016, FCBHA was thrilled and honored to have Ms. Nancy Thaler, Deputy Secretary of the Pennsylvania Office of Developmental Programs, visit our office. Ms. Thaler spent the morning meeting with the Supports Coordination Organization discussing the renewed Everyday Lives Initiative and transformation of service delivery for individuals with intellectual disabilities. The conversation included information on the new supports intensity scale, the plan to improve the Individual Service Plan (ISP) to be more of a person-centered document, and changes in rate structures. Ms. Thaler also shared her views on the history of services and her outlook for the future.



The highlight of the morning was the panel of individuals and family members, joined by their support staff, who shared their real-life experiences in the Fayette County support network. Ms. Thaler spent the balance of her morning speaking with the family members and also addressed some questions from the group.

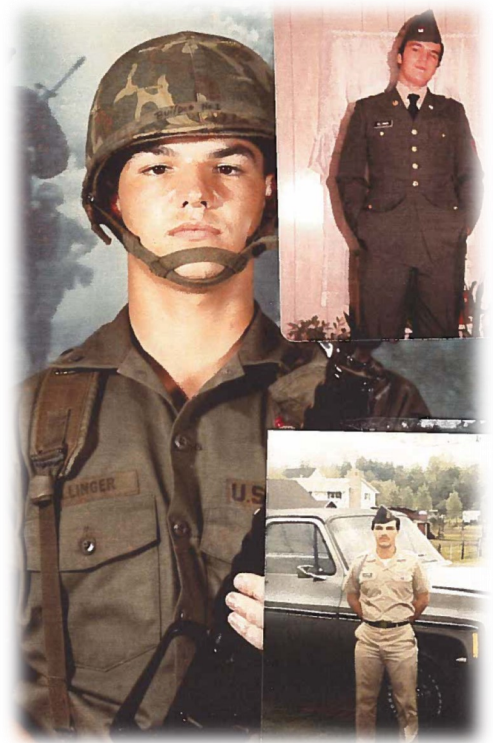

Integrated Care Comes to Fayette County

What is Integrated Care....The SOLUTION for many!

People with mental health and substance abuse disorders are likely to suffer much more than the average person from untreated and/or preventable chronic illnesses such as hypertension, diabetes, obesity, and others. that are aggravated by poor health habits and the complexities of healthcare systems. Fayette County individuals have an amazing opportunity in 2017. A partnership between Gateway Health and FCBHA will put a Licensed Clinical Social Worker on site at FCBHA to aid in the coordination of care between the physical and behavioral health systems. They will engage and educate behavioral health consumers receiving services so they can be more aware and proactive in caring for their health. INTEGRATION is expected to produce the best outcomes for people with multiple healthcare needs. We look forward to seeing outstanding results !

Murphy's Mental Health Bill Signed by President

The *Helping Families in Mental Health Crisis Act* recently passed into law as part of a larger healthcare reform package. This \$130 Billion / year legislation, seen as a game-changer, came about through in-depth investigation and congressional hearings that uncovered fatal disconnects between 112 federal agencies assigned to treat the mentally ill. They discovered a lot of wasted funds on feel-good fads that have done little to treat individuals. Upon signing the legislation, President Obama stated that this "takes steps to insure that mental illness and substance-use disorders are treated fairly by insurance companies". Many of these reforms align with the Obama Administration's work to improve the criminal justice system and also reauthorizes programs for suicide prevention. Other measures include a broadening of grant programs for law enforcement and first responders for training on response to mental health emergencies and extending short-term care allowance for severe mental health episodes. Finally, the legislation includes measures adding billions of dollars in new funding for medical research, other new health care legislation, and coordination among providers and agencies. The impact on HIPAA will be to allow for "compassionate communication" but this is a subject that most expect to require further clarification. The ultimate goal is to move more decision making out of Washington and back into the hands of states and consumers.
