Requirements

- Bank/branch capable of servicing these accounts within a one mile radius of the Courthouse.
- The bank must provide a designated account representative to serve as primary contact.
- The bank must provide a depository bond or pledge collateral in the amount of 100% of the total deposits in excess of FDIC limits.
- Provide direct deposit services for (weekly/biweekly) payroll and monthly retiree payments.
- Provide month-end statements with electronic images of checks and deposit tickets.
- Internet banking capabilities with appropriate system internal controls to maintain compliance with State and County Code regarding transfers of funds.
- Ability to interface with existing credit card merchant systems.
- Ability to open additional accounts as needed with the same terms as offered in the original proposal.

- The County must have the ability to make daily deposits (Monday through Friday) at a teller station in the bank.
- The County must have the ability to make after hour deposits 24/7(night depository facility).
- The bank must have the ability to provide dual presence to insure an accurate accounting of daily deposits with receipts of verification.

Bank Accounts

- Capability of bank accounts being either non-interest bearing and interest bearing and/or sweep accounts.
- Note the ability to provide Remote Deposit Capture services.

Include account type and recommendations for each bank account including any requirements and restrictions.
- Fees
Itemization of all fees that will apply.
- Rates of interest
State which accounts will pay interest.
Include the current interest rates (specify date of interest rate).
- Other services
Include any/all services the bank offices that would seem beneficial to the County.
