The bids received will be considered on an item-by-item basis and an award could be made to the lowest responsible bidder for each item or group of items bid.

**Submit one (1) original and five (5) copies of the completed bid form sheets** to the office of the County Controller, Courthouse, 61 East Main Street Uniontown, Pennsylvania 15401. Retain one copy for your files.

All prices **shall include shipping and handling to each building** (all buildings are within 6 miles of downtown Uniontown). The County may request samples of items that have not been used by staff in the past. Include one copy of the Material Safety Data Sheet on all items bid. All bidders may bid any or all items requested. There is no minimum or maximum amount purchased of each item throughout the year as well as for each order. Prices should be set for the fiscal year 2017 (1/1/17 to 12/31/17). **All deliveries are to be made within 5 working days from the date of receiving the purchase order.** Purchase orders will be called in, faxed or emailed. If you have a particular delivery date for this area please indicate the delivery date.

**The Fayette County Commissioners reserve the right to reject any or all bids or parts thereof. If you are awarded a product we may request a sample before ordering.**
