

**PUBLIC NOTICE IS HEREBY GIVEN** that the **Fayette County Board of Elections** will hold a **public hearing** to receive public comment on proposed changes to electoral district boundaries within **Fayette County, Pennsylvania**.

The hearing will be held as follows:

**Date:** December 11, 2025

**Time:** 1 PM

**Location:** Fayette Meeting Room, 2 West Main Street, Uniontown, PA 15401

A meeting of the Fayette County Board of Elections will commence at the conclusion of the public hearing.

The purpose of this hearing is to present and receive public input regarding proposed revisions to the boundaries of the following electoral districts in Fayette County:

Brownsville Borough	Precincts 1 and 3 to be consolidated as Precinct 1
Connellsville City	Precinct 2 and 3 to be consolidated as Precinct 2 Precinct 4 boundaries to stay same but re-number as Precinct 3
German Township	Precinct 1 and 3 to be consolidated as Precinct 1 Precinct 2 and 4 to be consolidated as Precinct 2
Luzerne Township	Precinct 2 and 4 to be consolidated as Precinct 2
Menallen Township	Precinct 2 and 3 to be consolidated as Precinct 2
North Union Township	Precinct 1 and 5 to be consolidated as Precinct 1
Redstone Township	Precinct 1 and 3 to be consolidated as Precinct 1 Precinct 2 and 4 to be consolidated as Precinct 2
Uniontown City	Precinct 1 and 2 to be consolidated as Precinct 1 Precinct 5 and 6 to be consolidated as Precinct 5, re-number as Precinct 2 Precinct 7 boundaries to stay same but re-number as Precinct 5

These changes are being considered pursuant to the Election Board's authority to petition the Court of Common Pleas to consolidate adjoining election districts or form an election district out of two or more adjacent wards, so as to suit the convenience of the electors and to promote the public interests, under **25 P.S. §2702 and §2704** and other applicable provisions of the Pennsylvania Election Code.

Maps of the proposed district boundary changes, along with related materials, will be available for public inspection beginning December 5, 2025 at the **Fayette County Election Bureau**, First Floor, Fayette County Courthouse, 61 East Main Street, Uniontown, PA 15401, during regular
