ASD can often be reliably be diagnosed by age 2.

Early identification of ASD helps children get the services they need.

Children with ASD can learn and succeed in the classroom and beyond. With the help of their families, providers, doctors and communities, kids with ASD can thrive.






The Fayette County Local Interagency Coordinating Council (LICC) is comprised of families of children receiving Early Intervention services and various professionals representing the Infant/Toddler and Pre-School (Birth to Kindergarten) community. The LICC recently hosted a Spring meeting at Fayette County Behavioral Health Administration for our Early Intervention families on April 9, 2025. Our topic for this meeting was 'Tools and Strategies for Coping with Behavioral Challenges'. Charity Ridenour and Amy Erickson from the Intermediate Unit #1 presented on different ways to address negative early interventions children's behavior in the most positive ways. They also completed a sensory activity with the children. Ann Amatucci, Occupational Therapist from Therapy Connections demonstrated how all behavior can be viewed as communication. The children enjoyed interacting with Ann, and it was a great experience for all. Eight families participated in the meeting, and they enjoyed pizza and other snacks while they shared their Early Intervention experiences. The next LICC meeting was a picnic on June 4, 2025 at Areford Park in Uniontown, PA, with a presentation on Summer Safety.
