JOB DESCRIPTION

- The Youth Commission is comprised of groups of volunteer citizens who assist the Juvenile Court in processing, disposition, and supervision of children between 10 and 18 years of age who have been referred to the Juvenile Court for the first time for the commission of minor offenses. These groups, based geographically within the County, range in size from 6 to 10 members. There are currently Youth Commissions in Albert Gallatin, Brownsville, Connellsville, Laurel Highlands, and Uniontown.
- These groups conduct hearings on a regular basis not to decide whether the referred child is guilty or innocent, but to address their delinquent behavior by directing them to become involved in any of a number of pro-social activities, including community service, journal writing, counseling, tutoring, and athletics. Each child is assigned a Community Probation Officer, a member of the Youth Commission responsible for meeting with the juvenile on a regular basis to ensure that he or she complies with the direction given during the hearing.
- There are presently volunteer opportunities available in each of the Youth Commission Districts.
