Addendum No. 1

The following is in response to questions from the bidders. This Addendum is hereby made part of the construction documents.

Questions from Bidders

1. Question: Is the deadline for all work awarded to be completed by December 15, 2020?
Answer: The December 15, 2020 deadline schedule is required for the County to complete documentation for the CARES Act Funding.

2. Question: What other types of financial surety is permissible by selected Contractor to submit if there is an executed contract with Fayette County?
Answer: In lieu of the bonding requirements, as stated in the Bid Document, the County will accept ten percent (10%) of a financial security of the total awarded for the five years after all hot spots are operational. The requirement for a Bid Bond is being waived.

3. Question: When do all hot spots need to be installed and operational in the base bid?
Answer: The selected Bidder will meet with the County and others to discuss the progress of the install and operation of the hot spots no later than November 1, 2020. At this time, it will be determined if the awarded scope of work can be completed by December 15, 2020. At this time, the County reserves the right to remove hot spots to remain on schedule to which a change order will be issued to decrease the amount of the contract. Any location remaining in the Project after this date must be completed as part of the Project.

4. Question: Is there a priority of the identified hot spots in the base bid?
Answer: All twenty-five hot spots are a priority to address the underserved and unserved areas in Fayette County. The County will coordinate with the successful Bidder on the order of completion.

Addition to the Scope of Services:

1. Mobilization added to the Base Bid and Alternate Bid Tabulation.

2. The successful Bidder will be responsible for providing the County all documentation required for reporting in accordance with the CARES Act.
