PREPARATION OF PROPOSALS

Proposals must be placed in a sealed envelope and marked: RFP 21-02. The name and address of the vendor must be marked on the sealed envelope.

DELIVERY OF PROPOSALS

Vendors shall provide references that show experience auditing these types of offices and accounts. Vendors must have proven experience in auditing these types of offices and accounts to be considered.

Fayette County accepts no responsibility for any expense incurred by the vendor in the preparation and presentation of a proposal and any such expenses are to be borne exclusively by the vendor.

NON-COLLUSION AFFIDAVIT

Each vendor is required to execute a Non-Collusion Affidavit in the form provided with the proposal. Any proposals received not containing a properly executed Non-Collusion Affidavit will be rejected.
