We encourage you to take the time to share your valuable perspective.

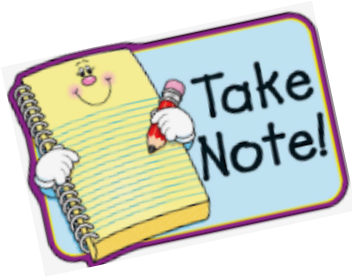

## Changes to HealthChoices Physical Health Plans

Changes to HealthChoices physical health plans are due to take effect on September 1, 2022. Mailings from PA Enrollment Services are underway.

Physical plans cover medications, including those for mental illness. It's important for consumers to actively choose a plan to avoid being auto-assigned a plan that may not include their current providers in its network. Aetna and United HealthCare will no longer serve Fayette County.

## Community Based Care Management



What is Community Based Care Management? Community Based Care Management (CBCM) assists Fayette County Residents who have a mental health diagnosis and/or substance use disorder with securing access to their identified Social Determinants of Health. A social determinant of health includes: safe and secure housing, employment, clothing, food, child care, utility assistance, access to physical health care, transportation, and financial strain.

The CBCM team will assess, refer, and mitigate obstacles to fundamental Social Determinants of Health. Fayette County's CBCM team is comprised of professional and community members with a variety of expertise and experience in the human service field. Fayette County Behavioral Health Administration, Fayette County Community Action Agency, Mental Health Associate of Fayette County, and The East End United Community Center work together to secure resources to meet the needs for Fayette County residents. There will also be trainings held at Fayette County Behavioral Health Administration in September to help you determine if someone is considering suicide so they may be referred for help. Visit our website for details.

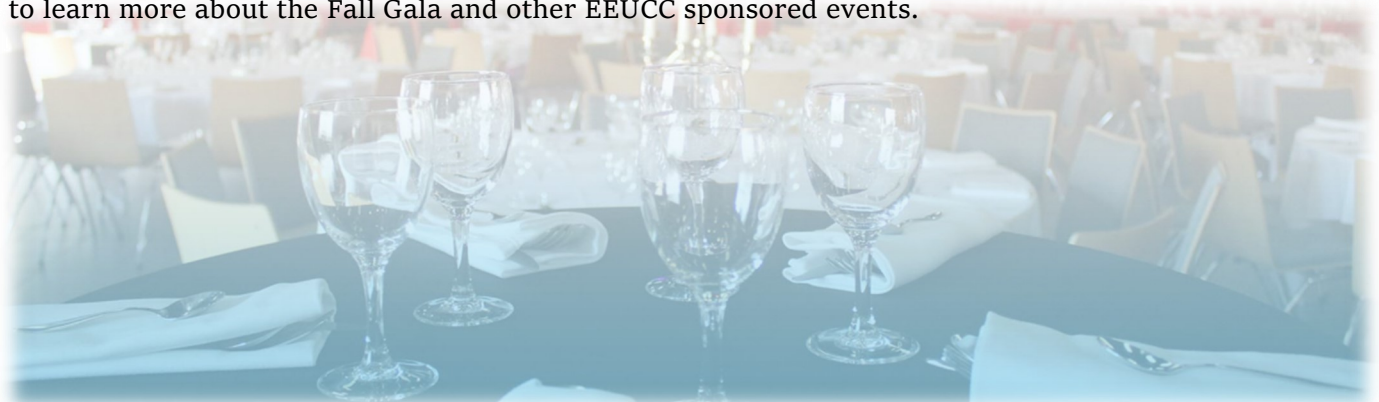
