Approval of the Minutes from the May 23, 2023, Meeting:

Meeting minutes were emailed to the Board prior to this meeting.

Motion made by Robert Lesnick to approve the minutes, seconded by Mark Rowan

Motion passed unanimously.

Ratification of the Board Decision to count May 13, 2023, Provisional Ballot of: Gary Huffine, Republican, of Dawson Borough, who voted a provisional ballot within his district.

This ballot was found in polling place materials after the board had left the Election Bureau at the conclusion of their previous meeting. It was unanimously decided. This was done through emails as there was a deadline, to have the ballot be given full count. The ballot was handled thusly:

The provisional ballot was placed information side down inside the large exterior provisional ballot envelope, which was placed information side down on a table. Two Election Bureau employees who had had no previous contact with this ballot were called to the Ballot Room, instructed to remove the ballot from its envelope and place it in a random spot within the stack of full count provisional ballots. This was to ensure the voter's choices remained anonymous.

A **motion** was made by Robert Lesnick to ratify the board's action in accepting and counting the ballot, seconded by Mark Rowan.

Motion passed unanimously.

Consider Cumulation of Write-In Votes Per attached Schedule.

The Election Bureau Director explained to the Board that the compilation of names was from the adjudication process from the write in votes, whether the outcome of a particular race was affected or not.

Mark Rowan stated there should be no discussion of whether a race will be affected by the Board's decisions. The Board does not want to look at, discuss, or know how their decisions will impact the outcome, only how the names should be cumulated.

Motion passed unanimously.

For the 6-year term: The Election Bureau researched the names for Mr. Hartman, on the ballot as Lawrence Larry Hartman, Jr. It was discovered there are two registered voters within this district named Lawrence A Hartman, and Lawrence A Hartman, Jr. There is no way to determine if Larry Hartman: 2, and Lawrence Hartman: 1, are attributed to the candidate.

Motion made by Mark Rowan and seconded by Robert Lesnick to accept the spellings for Mr. Hartman that have generational designations: Lawrence Hartman, Jr.: 3 - Larry Hartman, Jr.: 4 – Lawrence Larry Hartman, Jr.: 5. These equal 12 votes for Lawrence Larry Hartman Jr.

Motion made by Mark Rowan and seconded by Robert Lesnick to accept the spellings for Mr. Hartman that have generational designations: Lawrence Hartman, Jr.: 3, Lawrence Larry Hartman, Jr.: 4. These equal 7 votes for Lawrence Larry Hartman, Jr.

The Election Bureau researched the names for Mr. Hayden, on the ballot as William A Hayden. It was discovered there are two registered voters within this district named: William A. Hayden and William B. Hayden. There is no way to determine if Bill Haden: 2, William Hayden: 5, and Wm. Hayden: 1 are attributed to the candidate.

Motion made by Mark Rowan and seconded by Robert Lesnick to accept the spelling for Mr. Hayden: William A. Hayden: These total 7 votes for William A Hayden.

The Election Bureau researched the names for Mr. Travalena, on the ballot as Richard J Travalena, Jr. It was discovered there are three registered voters within this district named: Richard Travalena, Richard J Travalena, and Richard James Travalena, Jr.

The Board determined the misspelling of the last name was not significant enough to not count the votes, and the variations in the first names were considered nicknames for the given name, Richard.

Motion was made by Mark Rowan and seconded by Robert Lesnick to cumulate for Mr. Travelina the following name variations: Richard Travalena, Jr.: 13 – Richard Travelena, Jr.: 4 – Richard J Travalena, Jr.: 11 – Rich Travelena, Jr.: 4. This equals 32 votes for Richard J Travalena Jr.

Motion was made by Mark Rowan and seconded by Robert Lesnick to accept all cumulations of Charles R. Bock Jr. This equals 22 votes.

The Board determined that Rich is an acceptable nickname for Richard.

Motion was made by Robert Lesnick and seconded by Mark Rowan to accept Richard McQuillis and Rich McQuillis for Richard McQiillis, equaling 22 votes.

Motion passed unanimously.

As there was discussion concerning the signatures of both Mr. Lynn's, Tamara Kaufman, an Election Bureau employee who has had the most contact with Mr. Lynn was called into the room. She was able to positively identify which Mr. Lynn is the write-in candidate. (Allen J Lynn, Sr, 1958 DOB)

Mark Rowan wanted to note that based on the candidate filing a name variation sheet and a write in candidate declaration, the Board was able to compare signatures to identify Junior versus Senior. As the board has been rejecting the idea of differentiating Junior versus Senior unless so designated, if it is done in this case, it is because it has been through the research to determine which signature matches that of Allen J Lynn, Sr.

A **motion** was made by Mark Rowan and seconded by Robert Lesnick to accept the following cumulations for Mr. Lynn: Allen J Lynn: 20 – JoJo Lynn: 6 – Joe Lynn: 3 – Allan J. Lynn: 2. This is a total of 31 for Allan J Lynn.

Motion made by Mark Rowan and seconded by Robert Lesnick to accept the cumulations for Matthew Spaw, 25 votes.

Motion passed unanimously.

There was a discussion that write-in cumulations, as voted upon at this meeting, were to be published on the website.

The meeting was recessed at 2:45PM.

The meeting resumed at 2:55PM.

The Election Board has decided the Election Bureau shall post the list of cumulations to the Fayette County website, voted on today, that shows which votes were not/collected so that any interested candidate is able to see what votes were cumulated.
