JUNE 27, 2025 ADVERTISEMENT FOR BID

Sealed bids will be received in the Office of the Controller, Fayette County Courthouse, Uniontown, Pennsylvania, until 3:00 p.m. on Thursday, July 10, 2025 for the furnishing of all labor, materials, tools, equipment, transportation, supervision, and the complete performance of all work specified in the Contract for the construction of a paved walking trail and paved accessible parking areas at the Mill Run Athletic Field for Springfield Township, 755 Mill Run Road, Mill Run, PA 15464. BID Number 25-09.

All bids more than \$1,000 must be accompanied by cash, certified check, or bond with corporate surety in an amount no less than ten percent (10%) of the amount bid.

The bids will then be publicly opened and read aloud in the Fayette County Commissioners' Office Conference Room, 1st Floor Courthouse, Uniontown PA 15401 at 3:00 p.m.

Bid forms and specifications may be obtained from the Chief Clerk of Fayette County, Courthouse, Uniontown, PA 15401 by calling 724-430-1200 ext. 1504 or by emailing aliston@fayettepa.org. Bid specifications can also be found on the county website at www.fayettecountypa.org.

Bids must be made on standard proposal forms, in the manner designated therein, and required by the specifications, must be enclosed in sealed envelopes, bearing the name and address of the bidder and the name of the project on the outside, addressed to Fayette County and must be accompanied by a Non-Collusion Affidavit and a bid bond or certified check for not less than ten percent (10%) of the base amount bid, and be delivered at the place on or before the hour named above.


Bid prices shall be entered into the space provided on the form. An award will be given to the lowest bidder. The successful bidder must provide shop drawings within 21 days of the notice to proceed. Submit one (1) original and five (5) copies of the bid form to the Office of the County Controller, courthouse 61 East Main Street Uniontown PA 15401. Together with bid deposit. Retain one copy of the bid for your files. All bids submitted pursuant to this advertisement and delivered to the Controller's Office must be in an Enveloped Sealed and Clearly Marked on the outside of the envelope Bid No. 25-09.

The successful Bidder will be required to furnish satisfactory Performance and Labor and Material Payment Bonds. The Fayette County Commissioners reserve the right to reject any or all Bids, including without limitation, nonconforming, nonresponsive, unbalanced, or conditional Bids. Owner further reserves the right to reject the Bid of any Bidder whom it finds, after reasonable inquiry and evaluation, to be non-responsible. Owner also reserves the right to waive all informalities not involving price, time, or changes in the Work and to negotiate contract terms with the Successful Bidder.
